BUSINESS LICENSE APPLICATION

An application for a Business License is required pursuant to the Authority of the Code of Ordinance; Chapter 69-I- Licenses Required. This ordinance requires that Business Licenses be renewed each year as adopted by the Mayor and Town Council.

It shall be the applicant's responsibility to contact Calvert Count Government for additional permits necessary to carry on the Business, Trade or Profession, at the identified premises and provide the Town a copy. This application must be completed in its entirety, signed and returned with full payment based on the fee schedule. Please make checks payable to the Town of North Beach. A license will be mailed or delivered to the address shown as the business address upon completion of a passing inspection performed by our Code Enforcement Officer.
