- End Hunger Dragon Boat Festival will be a one-day event held on June 8, 2024.



- Participating vendors shall indemnify and hold harmless the Town of North Beach and its officials, employees, and agents from any and all liabilities, judgments, settlements, losses, costs, or charges (including attorneys' fees) incurred by the Town of North Beach or any of its officials, employees or agents as a result of any claim, demand, action or suit relating to any bodily injury (including death), loss or property damages caused by, arising out of, related to or associated with the use of the property or the participation of the vendor or by the vendor's employees, agents or invitees at the End Hunger Dragon Boat Festival 2024.
- Vendor is responsible for himself/herself and his/her employees, his/her subcontractors, materials, equipment, and all insurance to protect him/her and/or others.
- Payment will be refunded, if out of necessity that the vendor must cancel, provided End Hunger In Calvert County has been notified prior to June 1, 2024. No refunds will be given after June 1, 2024.
- Payment should be submitted with your application. **All applications should be received no later than 4:30 pm on Monday, June 3, 2024, NO APPLICATIONS WILL BE CONSIDERED AFTER THAT DATE.** All checks should be made payable to End Hunger In Calvert County, Credit Card payments are accepted at the End Hunger In Calvert County with a 3% fee included.
- **All space assignments are final.** Spaces are assigned based on items sold. **There will be no reassignments.**
- Vendors are responsible for bringing their own tables, chairs, tablecloths, and plastic covers or something to keep your merchandise dry in case of rain. **THIS IS A RAIN-OR-SHINE EVENT.** Tents or canopies may be used and must be secured for safety and to avoid injury or damage to property and/or patrons. Vendors are required to make immediate safety changes when directed to do so by Festival or Town of North Beach personnel.

All vendors are required to complete the Vendor Survey Form and return it with their completed contract and payment. Photos of setup and all merchandise being sold are **MANDATORY**.



- Set up time is 6 am to 8 am and all vendors must be completely set up by 8 am.
- No electricity is provided, and generators are not allowed without advanced written permission from Stacy Milor at The Town of North Beach: Stacy Milor, CPM, MMC

- All vehicles must be off the street by 8 am. If a vehicle is part of the display and the vehicle is larger than 10 feet, you will need two (2) spaces. Any units larger than 10 feet must arrive by 6:00 am for set up.
- The Vendor list will be mailed to the State of Maryland. The 6% Maryland State Sales Tax must be collected and reported to the State of Maryland by all Vendors.
- The following items ARE NOT allowed to be sold at this Event: Any type of silly string; fart gas; artificial tobacco products of any type; snap pops or pop-its; any type of drug paraphernalia; any form of firecracker or fireworks; no live animals/reptiles/birds; t-shirts or other items containing sexual content or profanity; no swords or knives; additional items may be prohibited, and each item will be reviewed. Any vendor found selling these items or the like, will be asked to leave the festival and will not be entitled to any refunds.
- Each vendor is responsible for removing **ALL** their own trash. A Dumpster will be provided. Trash is **NOT** to be left on the street.
