The following is a list of task the Public Works Department has been working on in addition to routine task.

- Dug up and repaired sewer lateral that serves the Boys and Girls club building. Sewer line had become damaged from heavy vehicle traffic. Repaired pipe and backfilled. Made a new entrance on the north side of building for deliveries to help prevent this in the future.
- 2) Installed new surface drain and piped to existing drain on Atlantic Ave. north of 9th street. This has been a problem area due to elevations in area. This should help with standing water in this location.
- 3) Preformed a smoke test on the town's sewer system with the help of Maryland Rural Water Association. Went through entire system and checked for possible problems. Came up with a list of issues which were identified from test. Most issues where minor and DPW has started correcting problems. In two areas smoke appeared to be coming from storm drain catch basin. DPW will clean and camera in this areas to find possible problems.
- 4) Installed speed bumps along Bay Ave in high pedestrian traffic area from 3rd street to just north of 5th street.
- 5) Continue to work with Paul on new sewer agreement with Calvert County. Met with Calvert County water and sewer division chief and Calvert Health Department about water service west of Greenwood Ave. Main issue is the area west of Greenwood is zoned as W1, which means water is available and no new wells are allowed. Problem is there is no infrastructure in place.
- 6) DPW crew has also been busy with routine grounds maintenance items throughout town.

The following is the status of activities that are being worked on:

Maryland SHA Rte. 261 SHA Upgrade Project (9th Street to Anne Arundel County)

SHA's environmental and highway design work is progressing toward a planned construction start for the spring of 2020. The SHA held a design update meeting in June to discuss design progress. Most of the meeting revolved around the Maryland Department of Transportation Town hall Meeting held on June 21, 2018. The main topic included the proposed detour during Construction. A resolution by the town is being requested to be forwarded to the Maryland Department of Transportation secretary Peter Rahn to show Town support for the project and request existing pole utilites be placed underground.

Maryland SHA Rte. 261 Boardwalk (9th Street to Anne Arundel County)

Preliminary design is complete and TAP (Transportation Alternatives Program) grant Monies will be sought for 2018. The Town has prepared a new grant package to the state this month. No new update.

Stormwater Flood Pump Upgrade (9th & Atlantic)

The existing stormwater pump station is not designed to adequately handle frequent localized flooding. We have begun to analyze the system and provide upgrade proposals for consideration and to request monies to be budgeted in the coming fiscal year and to (100K) we are looking at possible grant opportunities. We have finished the Atlantic Avenue survey and drainage design to improve surface drainage along the road. The improvement has now been installed.

Public Works Yard - Well Building

We have prepared preliminary engineering construction budget to upgrade and raise the existing 30+ year old well house building. Design is underway and Grant monies are being sought to assist with this project. Ongoing

Storm Drain System Maintenance:

We are working with Donnie and public works to develop a storm drainage maintenance and improvement plan for Fy 18 and Fy 19. Ongoing.

Sewer Meter

We are evaluating the location and type of sewer meter that could be placed within (6) existing manhole locations to determine the sewage effluent flow characteristics that Calvert County is delivering to the Town sewage system. The Calvert County effluent mixes with the town effluent before being pumped together to the Waste Water Reclamation Facility in Chesapeake Beach. We are currently waiting for the school water Tower flow information from the County

Library Site:

We are working with Calvert County to develop a Memorandum of understanding to move the project forward.



- NB Trademark: Both trademarks have been published for opposition (they've cleared the review process at the
 Trademark Office and are published so that the public has an opportunity (30 days) to oppose the granting of the
 trademarks on grounds that they are "too close" to their own marks). Assuming that they clear this opposition period (no
 reason to think they won't), we will receive a Notice of Allowance for each. We will then just have to file our evidence
 that the marks are actually being used and then the final registrations will issue.
- Continue to monitor inventory and sales at the Shirt Shack; re-order and re-stock merchandise as necessary. Meet with employees to review guidelines and train on register and scanner system. Meet with and negotiate merchandise and pricing with local supplier. Create new design for the back of shirts.
- Created advertisements for the Old Town Crier and What's Up Annapolis magazine. These ads promote the town, weddings and events.
- · Attended and photographed the Dragon Boat Festival.
- Designed the booth layout, banners and promotional material for the MML Convention. Attended the convention and worked the town booth.



Job Summary:

Provide and maintain public parks, gardens, playgrounds, and other recreational facilities and programs to promote the health, welfare, and enjoyment of the inhabitants of the Town through a comprehensive program of recreational activities in the town parks and waterfront. Oversee the preservation, maintenance, and operation of the town parks and nature preserve to provide compatible outdoor recreation and educational opportunities for the public. Manage the following areas/sites: Sunrise Garden, Callis Park, Overlook Park, Walton Beach Nature Preserve, and portions of the waterfront specifically related to some recreational activities as described.

Duties and Responsibilities:

General: Develop programs to make North Beach an outdoor recreational destination for clubs to include birding & wildlife photography, walking, running, biking, kayaking, power boating/PWCs. Consider organizing promotional run/walk/other events and work with clubs to do the same in NB. Work with NB Marketing/PR POC and possibly the Economic Development Committee to achieve this.

Event Coordinator for future organized recreational activities, environmental & wildlife education, etc. Examples of this might include hosting or organizing guided bird watching at Walton Beach or Overlook park, hosting or organizing talks on the lifecycle of the horseshoe crab and osprey, hosting or organizing an event around the NB Town Hall green roof, or other events not currently taking place in NB that highlight it's unique recreational, natural and green resources.

Work with North Beach webmaster to create a Parks & Recreation section on the NB website that details recreational and educational opportunities provided through NB Parks and Rec similar to that of Calvert County Parks and Rec.

Develop a relationship with local law enforcement to help reduce crime/misuse of all NB parks.

Be familiar with the Sustainable MD program. Take the lead in ensuring North Beach continues to strive for the goals it set when earning its certification. Work with the development specialist, Environmental Committee, town staff, and others to achieve the multi-year goals already published.

All Parks: Develop and oversee a shared security check schedule with the waterfront manager. Conduct those checks according to schedule.

Ensure the parks are maintained with an attractive, clean and trash free appearance

Ensure appropriate signage is postage at all parks of two types: rules, and informational/educational. Where non-existent, design & install new signage in cooperation with committees, clubs and town departments as necessary.

Enforce usage rules (and laws) for all parks are followed through scheduled visits during all hours. Coordinate with waterfront staff and local law enforcement to achieve this.

Host environmental & wildlife talks, school field trips, and other events. Also use NB Town Hall when appropriate. Examples of this include the lifecycle of the horseshoe crab, native birds of the Chesapeake (perhaps with guest speaker from a birding club), the history and current state of the Walton Beach Nature preserve.

Work with Boys and Girls club and Senior Center to create opportunities for environmental and wildlife education as well as outdoor recreation.

Waterfront: Provide environmental & wildlife education at the beach, enforce no-feed regulations. Support organized/club recreational activities at designated launch areas.

Be a visible presence to the general public on the boardwalk, enforce rules and answer questions.

Ensure proper usage of the bike path. Ensure organized bike rides safely use (or not use, as appropriate). POC for organized bike ride planning through town to ensure safety of all.

Enforce fishing regulation/licenses. Develop, promote, and codify a lead free fishing program.

Develop a program to promote, utilize and manage the boat slips for residents and visitors/transients, to include PWCs (personal watercraft, aka jet skis), and human powered small craft.

Sunrise Garden & all contracted grounds maintenance areas: Ensure attractive overall appearance.

Oversee maintenance contract(s), or provide onsite quality control if shifting contract management responsibility is not desirable.

Ensure that sunrise garden adheres to Bay-Wise best practices (https://extension.umd.edu/baywise/home-landscape-best-management-practices) and continues to maintain its certification.

Ensure all fountains, sprinklers, security, lights and other systems are operational; coordinate & make repairs w/public works.

Participate in Plant the Town. Work with Garden Club leaders and Greenstreet Gardens or other leads to help where possible. De-conflict bicycle route issues for frequently coincident bike fundraiser ride through NB on same day.

Callis Park: Ensure attractive overall appearance. Ensure all park equipment is safe in accordance with appropriate standards. Ensure all security, lights and other systems are operational; coordinate & make repairs w/public works.

Walton Beach Nature Preserve: Oversee maintenance contract(s), or provide onsite quality control if shifting contract management responsibility is not desirable.

Ensure Walton beach is maintained and protected to the standards defined by both Environmental Concerns, Inc. and Calvert county parks (and other authorities as appropriate).

Ensure the tidal flow areas at Walton remain free of obstructions.

Ensure road raising project and design and final construction near Walton Beach does not remove public access or prevent recreational opportunities consistent with its founding documents. Further, ensure the design is such that it facilitates these usages, or can be the starting point for the town to do additional work to encourage these uses.

Overlook Park: Develop programs to attract birders and nature photographers to Overlook Park (and Walton Beach). Develop relationships with local clubs supporting these activities. Work with NB Marketing/PR POC to achieve this.

Town Hall green roof: Develop a program to raise the visibility of the North Beach Town Hall's green roof for educational purposes. Ensure this site is properly maintained.

Trees throughout the town: Take the lead in investigating the viability of North Beach restoring its tree city program. If viable, develop a program to do so. Coordinate with the Environmental Committee, town volunteers.

Hours, days of the week, months:

One possible approach to allocating hours for the position based on budgeted salary (\$35K) and benefits:

Based on a 50 week year, 3 x 8hr days per week = 1200 hours, plus an additional 300 hours (37.5 days) to be allocated to events support any time of year or additional days/hours during summer. This equates to about \$23/hr. (before taxes), an acceptable starting point if it proves adequate to attract and retain a qualified individual. This year-round approach would more likely allow the employee to pursue other part time work as compared to full-time park ranger duties over a narrower portion of the year (beach season only, for example).

Park Ranger - Position in the Organization



ORDINANCE 18-04

AMENDING CHAPTER 17, "PERSONNEL POLICIES," TO CREATE ARTICLE I, "POLICIES AND PROCEDURES", AND ARTICLE II. "COMPENSATION OF ELECTED OFFICIALS"; AND TO ADD SECTION 17-100, "COMPENSATION OF COUNCIL MEMBERS" AND SECTION 17-101, "COMPENSATION OF THE MAYOR", TO IMPLEMENT THE PROVISIONS OF SECTIONS 19-302 AND 19-402 OF THE TOWN CHARTER.

WHEREAS, the Town of North Beach, Maryland (the "Town") is a municipal corporation in the State of Maryland; and

WHEREAS, pursuant to Md. Code Ann., Local Gov't Art., Section 5-202, "General Authority of Municipalities", the Town Council has the authority to pass such ordinances as it deems necessary to preserve peace and good order, to secure persons from danger and destruction and to protect the health, comfort and convenience of the residents of the municipality; and

WHEREAS, Section 19-302 of the Town Charter permits the Town to set salaries for Town Council members by ordinance and Section 19-403 of the Town Charter permits the Town to set a salary for the Mayor by ordinance; and

WHEREAS, the Town's elected officials have never received a salary for the performance of their functions; and

WHEREAS, over the years since the incorporation of the Town, and particularly in the recent decades as the Town has grown in size and its affairs have grown in complexity, the investment of time required to adequately fulfill the roles of elected officials has increased dramatically; and

WHEREAS, local elected officials performing comparable function in comparable jurisdictions are commonly compensated for their time, a practice which encourages the participation of a larger pool of interested individuals in local politics and, consequently, increases the alternatives available to local voters; and

WHEREAS, the Town Council has determined that it is in the best interests of the Town and its residents for persons occupying the Town Council during elective terms following and not including the present term to receive fair and adequate compensation for their time.

Section 1. NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Town Council of North Beach, Maryland, that Chapter 17, "Personnel Policies", be and is hereby amended to add Article I, "Policy and Procedures", to read as follows:

ARTICLE I. POLICIES AND PROCEDURES

Section 2. BE IT FURTHER ORDAINED AND ENACTED by the Town Council of North Beach, Maryland, that Chapter 17, "Personnel Policies", be and is hereby amended to add Article II, "Compensation of Elected Officials", Section 17-100, "Compensation of Town Council Members" and Section 17-101, "Compensation of the Mayor", to read as follows:

ARTICLE II. COMPENSATION FOR ELECTED OFFICIALS.

SEC. 17-100. COMPENSATION OF TOWN COUNCIL MEMBERS.

BEGINNING ON DECEMBER 16, 2018, EACH TOWN COUNCIL MEMBER SHALL RECEIVE COMPENSATION IN THE AMOUNT OF THREE THOUSAND DOLLARS (\$3,000.00) PER ANNUM, PAYABLE IN EQUAL BI-WEEKLY INSTALLMENTS ON EACH REGULAR TOWN PAYDAY, SUBJECT TO APPROPRIATION OF FUNDS IN THE TOWN'S ANNUAL BUDGET FOR THIS PURPOSE.

SEC. 17-101. COMPENSATION OF THE MAYOR.

BEGINNING ON DECEMBER 16, 2018, THE MAYOR SHALL RECEIVE COMPENSATION IN THE AMOUNT OF EIGHTEEN THOUSAND DOLLARS (\$18,000.00) PER ANNUM, PAYABLE IN EQUAL BI-WEEKLY INSTALLMENTS ON EACH REGULAR TOWN PAYDAY, SUBJECT TO APPROPRIATION OF FUNDS IN THE TOWN'S ANNUAL BUDGET FOR THIS PURPOSE.

TOWN OF NORTH BEACH RESOLUTION 18-05

FOR THE PURPOSE OF ADOPTING THE CALVERT COUNTY, MARYLAND 2017 HAZARD MITIGATION PLAN UPDATE

- WHEREAS, Calvert County is vulnerable to natural hazards such as coastal erosion, flooding, extreme weather conditions, and wildfires that can result in property loss, loss of life, economic hardship and threats to public health and safety; and
- WHEREAS, Calvert County has been faced with threats to life and safety and property damage from other natural and man-made hazards, including high winds, shoreline erosion and hazardous material incidents; and
- WHEREAS, the Disaster Mitigation Act of 2000 requires local and state governments to prepare and adopt hazard mitigation plans as a condition of receiving Pre-Disaster Mitigation Grant assistance and Hazard Mitigation Grant Program assistance after November 1, 2004; and
- WHEREAS, the Calvert County Department of Public Safety, Emergency Management Division received grant funds to update the County's Hazard Mitigation Plan in compliance with current disaster mitigation regulations; and
- WHEREAS, the Countywide Hazard Mitigation Planning Team which, includes representatives from the Town of North Beach, has prepared and recommended the Calvert County, Maryland 2017 Hazard Mitigation Plan Update that reviews Calvert County's options to protect people and reduce damage from flooding and other hazards including shoreline erosion, high winds and hazardous materials incidents; and
- WHEREAS, the recommended Calvert County, Maryland 2017 Hazard Mitigation Plan Update identifies cost-effective actions Calvert County can take to eliminate or reduce the long-term risk to life and property affected by the natural hazards that face the County; and
- WHEREAS, the recommended Calvert County, Maryland 2017 Hazard Mitigation Plan Update was the subject of public information meetings held in Calvert County, Maryland on September 29, 2017 and November 28, 2017; and
- WHEREAS, the recommended Calvert County, Maryland 2017 Hazard Mitigation Plan Update has been widely circulated for review by federal, State and regional agencies and has been supported by those reviewers; and

WHEREAS, the Mayor and Town Council of North Beach, Maryland believe it is important for the County to be prepared for and mitigate against hazards by adopting and implementing the Calvert County, Maryland 2017 Hazard Mitigation Plan Update.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Town Council, for the Town of North Beach, Maryland that the *Calvert County, Maryland 2017 Hazard Mitigation Plan Update* on file with the Calvert County Department of Public Safety is hereby adopted; and

BE IT FURTHER RESOLVED, that the Mayor and Town Council will appoint such representatives to the Calvert County Hazard Mitigation Planning Team as are included in R-09-05 of the Board of County Commissioners of Calvert County or any superseding resolution of said body; and

BE IT FURTHER RESOLVED, that the Town's representatives of the Hazard Mitigation Planning Team shall participate in meeting of the Planning Team as often as necessary to prepare or review mitigation activities and progress toward implementing the *Calvert County, Maryland 2017 Hazard Mitigation Plan Update*, but not less than once a year; and

BE IT FURTHER RESOLVED, that it is the intention and desire of the Mayor and Town Council that, by April 30 each year, the Planning Team shall prepare an annual evaluation report to the Board of County Commissioners of Calvert County on the *Calvert County, Maryland 2017 Hazard Mitigation Plan Update;* and

BE IT FURTHER RESOLVED, that it is the intention and desire of the Mayor and Town Council the annual evaluation report shall include: a review of the original plan; a review of any floods; other major natural hazard events; or hazardous materials incidents that occurred during the previous calendar year; a review of the action items in the original plan, including how much was accomplished during the previous year; a discussion of why any action items were not completed or why implementation is behind schedule and recommendations for new projects or revised action items. Such recommendations shall be subject to approval by the Board of County Commissioners of Calvert County as amendments to the adopted plan; and

AND BE IT FURTHER RESOLVED, that this Resolution shall take effect upon recordation.
