**DON'T LEAVE HOME WITHOUT YOUR MASK!**

All Marylanders over the age of five are required to wear face coverings in the public spaces of all businesses across the state. Face coverings will also be required in outdoor public areas, whenever it is not possible to maintain physical distancing. The expanded order continues to provide certain exceptions, including for medical conditions.

**The mask order includes the boardwalk. If you are walking, running, sitting or standing on the boardwalk in the Town of North Beach and are not able to maintain physical distancing, you must wear a mask. If you are able to maintain physical distancing, always have your mask available when approaching others. We appreciate your cooperation!**



**MASKS ON, MARYLAND**

Effective July 31 at 5 p.m., Maryland's current masking order will be expanded to the following circumstances:

- 1 In the public spaces of all businesses.**  
Examples include retail stores, pharmacies, banks, and shared areas in offices.
- 2 In outdoor public areas when it is not possible to maintain physical distancing.**  
Examples include busy farmers markets or marinas.

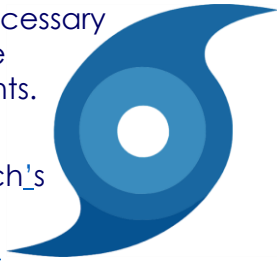
