GUIDELINES:

- **A ONE TIME FEE OF \$400.00 IS DUE ONCE ACCEPTED INTO THE MARKET** FOR A 24' WIDE X 10' DEEP SPACE. No electric is supplied for the Farmers' Market; however, generators are allowed.
- The market will operate on Fridays from 6-9pm starting May 1, 2020 and ending on September 25, 2020. Vendors may arrive as early as 4pm for set up and must be ready to sell at 6pm when the Town Official rings the bell. **THERE WILL BE NO SELLING PERMITTED BEFORE 6PM.** The Town reserves the right to accept or reject any application without explanation or comment. The Food/Drink Court will be located on the East end of 5th Street, North Beach, Maryland 20714, weather permitting. Should it become necessary to cancel the Market, it will be posted on the Town's website and Facebook page along with a group email sent to all vendors. All efforts will be made to send cancellation of the market at the earliest time possible.
- Organic and local products and produce are encouraged.
- Each Vendor will be assigned a space for the duration of their participation with the market. Tents or canopies may be used and must be adequately secured for safety and to avoid injury or damage to property and/or patrons. Vendors are required to make immediate safety changes when directed to do so by the Market Manager or Waterfront Personnel.
- Participating vendors shall indemnify and hold harmless the Town of North Beach and its officials, employees and agents from any and all liabilities, judgements, settlements, losses, costs or charges (including attorney fees) incurred by the Town of North Beach or any of its officials, employees or agents as a result of any claim, demand, action or suit relating to any bodily injury (including death), loss or property damages caused by, arising out of, related to or associated with the use of the property or the participation of the vendor or by the vendors employees, agents or invitees to the North Beach Friday Night Farmers' Market.

NORTH BEACH FRIDAY NIGHT FARMERS' MARKET FOOD VENDOR APPLICATION & TERMS CONT.

- All food and beverage vendors participating in this event will be required to meet all necessary requirements and regulations by the Calvert County Health Department. A permit to participate in the farmers' market must be received by April 1, 2020 to Stacy Milor, Event Manager. Failure to provide the Health Department permit will disqualify you from the Market. Any questions concerning the requirements of the Health Department should be forwarded to them directly at 301.855.1353. Payment required by the Health Department will be submitted directly to the Calvert County Health Department.
- Vendor is responsible for himself/herself and his/her employees, his/her subcontractors, materials, equipment and all insurance to protect himself/herself and/or others as well.
- All inquiries concerning the North Beach Friday Night Farmers' Market shall be directed to Stacy Milor. **ALL FOOD VENDORS MUST SUBMIT A COPY OF YOUR MENU WITH THIS APPLICATION.**
- Once a Food Vendor is approved and accepted into the Farmers' Market, a space will be assigned. All space assignments are **FINAL**. Spaces are assigned based on items sold. **THERE WILL BE NO REASSIGNMENTS.**
- **VENDORS WILL HAVE A ROTATION SCHEDULE.**
- **APPLICATIONS ARE DUE BY 4:30PM ON APRIL 1, 2020. NO APPLICATIONS WILL BE CONSIDERED AFTER THIS DEADLINE. (Please do not submit payment until after accepted into the Market)**
