- 1) Discussion regarding speed humps installations in San Francisco by the Bay: The Town Council approved the installation of speed humps pending the outcome of a survey from the community to determine if they would like to have them installed on Glouster Drive. There was a total of 30 votes returned from a community of 135 townhomes. Councilman Randy Hummel would like for the community to have a higher percentage of voting for the Town to complete the installation. Councilman Randy Hummel will suggest to the Homeowners association a paper ballot is distributed to the homeowners to achieve a higher ballot return. The association also a requested a reduction in the speed limit on Glouster Drive to 15 mph. John Shay will look at the Town regulations to see the process to change the speed limit on Town streets.

The representative from NLS Lighting Company along with some assistance from K & H has suggested to Donnie some lighting patterns and bulb wattage for the lights. The light selections may have to go out to bid if the Town cannot purchase the lights directly from the distributor. MOTION made by Mickey Hummel to purchase the California style light fixtures. The following is the status of activities that are being worked on:

#### Living Shoreline Project & Flood Dike project

Construction on the Flood Dike is has now be restarted as the revised wetlands permits have been obtained from the ACOE & MDE.

#### Maryland SHA Rt. 261 SHA Upgrade Project.

SHA's environment al and highway design work is progressing. The elevated walkway on the west side is not included in the current design efforts. SHA recognizes that the potential for this item exists. Efforts for the Town to apply for grant funding for the walkway are planned for the Spring of 2017.

#### Beach Dredge Project

, We are continuing with the Federal & State permit process before work can start,

#### Pier Pavilion Project

MDE has told us that the a 2500sf structure does not qualify for approval by MDE and the Board of Public Works under State Code Article 16-104. We are proceeding with the permitting process for a 1000sf Pavilion which is allowed under Article 16-104 on the north side of the Tee section. The first step is to amend the Towns Critical Area Ordinance See Critical Area items below.

#### Critical Area Requirements

I met with the Critical Area Commission Staff on April 6 to discuss the need for legislation to be approved by the Council for the Town's Critical Area Program. The legislative items include the following:

- 1. Reflect that the Burnt Oaks Project was elevated from its original Classification of Limited Development Area (LDA) to Intensely Developed Area (IDA) when it was built in the 1990's The need for this item became known as part of the new Critical Area maps (Item 2).
- 2. Reflect the new Critical Area maps that were provided to the Town by DNR in 2014.
- 3. Adjust the requirements in Town Zoning to meet current State mandated Critical Area requirements.
- 4. Adjust the requirements in Town Critical Area Zoning to allow for the installation of the proposed Pavilion on the Town Pier.

Critical Area staff is helping with drafting Ordinances and Resolutions for Town Council to approve for these items We expect these items to be ready for Council action at their May meetings


Monthly Report



#### **Green Team Mission Statement:**

The mission of the North Beach Green Team is to ensure the ongoing preservation of the town's wetlands, natural shoreline, and green spaces so that residents and visitors may enjoy them now and in the future. We promote a healthy, attractive, sustainable North Beach through green initiatives and public education.

#### **Green Team Vision Statement:**

North Beach is one of only two Maryland municipalities located directly on the shore of the Chesapeake Bay. Thus the well-being of our community is intimately related to that of the Bay itself therefore the vision of our Town over the next decade includes:

- <u>Partnerships</u> Continue to expand, enhance and grow partnerships with agencies, organizations, non-profits, residents, funders, and the community to assist us with the mission of creating a sustainable and healthy North Beach.
- Energy and Carbon Footprint Continue to build upon our municipal buildings with green elements, green infrastructure and LEED (Leadership in Environmental and Energy Design) components to reduce energy needs and reduce our energy consumption as a town.
- Food Encourage and increase locally grown food production through education and opportunities for community members to produce or purchase food produced organically and sustainably.
- <u>Bike & Pedestrian Friendly/ADA Compliant</u> Continue to be a strong advocate for walking and biking by developing a streetscape plan that encourages walking, bike paths/lanes and ADA infrastructure.

- <u>Habitat & Water</u> Continue to be a strong proponent of the preservation and protection of the Chesapeake Bay and its surrounding waterways.
- Reduce, Reuse and Recycle Continue to educate residents, visitors, and the community using the model of the three R's (reduce, reuse and recycle).

- 4. Evaluate the cost to the Town of an electric charging station for electric vehicles for municipal, residents and visitor usage.
- 5. Continue to assist and promote our local growers and farmers in creating organic foods.
- 6. Create, develop and fund hoop houses or local gardens for resident Adults, youth and families to participate in learning the skills in farming and growing food.
- 7. Promote and encourage the town to continue the Farmer's Market.
- 8. Investigate the need for an indoor farmer's market for the town during the fall and winter months.
- 9. Encourage street art and public engagement to create a cohesive branding strategy of a vibrant community.
- 10. Encourage the municipal leaders to continue their commitment to become more bike and pedestrian friendly, and make continued investments in creating green streets throughout the town.

- 11. Continue to work on ways to protect the Bay with wetlands and plantings.
- 12. Work with the NB House and Garden Club on events and to promote stewardship in homes with gardens, plants and trees.
- 13. Assist the town with the Annual event "Plant the Town" to plant trees, flowers.
- 14. Create a recycling education program for residents through print, video and other media.
- 15. Participate in the County's "Special Event Recycling Program" by providing recycling containers and recycling education at town sponsored events.
- 16. Support County and State goals towards waste reduction.
- 17. Continue to promote a clean Town, and encourage cooperation from the public through the Annual Community Clean-up Program and other educational tools, to protect the Chesapeake Bay from trash.

#### Phase Two Actions:

- 1. Hold a yearly Garden & Green Event for residents, community and visitors to participate in activities to learn about ways to reduce your carbon footprint.
- 2. Develop and create a home energy certification program as a way of showcasing energy or smart goals for the residents.
- 3. Develop and fund a program that assists homeowners in reducing their energy intake, through an energy audit and energy performance measures, to decrease their utility bills by 20 percent.
- 4. Continue to support the Green Schools in the area that educate our young people on the environment and being a steward of the environment. Attend the Green Team meetings at the schools.
- 5. Pursue grants for green infrastructure through various funding sources.
- 6. Protect and promote open spaces for art, water, gardens, and attractions by using art, signage, and environmentally friendly products.
- 7. Promote Bay-Wise Gardening, Wildlife Habitats, and other environmentally friendly "lawn-alternatives" in both the public and private spaces throughout town.

#### Phase Three Actions:

1. Design streets to incorporate stormwater and biorention measures for proper drainage.
