TOWN OF NORTH BEACH ORDINANCE NO. 21-06

AN ORDINANCE OF THE TOWN OF NORTH BEACH REPEALING CHAPTER 86, 'PEACE AND GOOD ORDER", OF THE CODE OF THE TOWN OF NORTH BEACH, TO REPEAL SECTION 86-2, "TRESPASS UPON BOATS", AS UNNECESSARY

WHEREAS, pursuant to Md. Code Ann., Local Gov't. Article, § 5-202, the Town of North Beach ("the Town") has the authority to pass such ordinances as it deems necessary to assure the good government of the Town; protect and preserve the Town's rights, property, and privileges; and preserve peace and good order; and

WHEREAS, pursuant to this authority the Town enacted Chapter 86, "Peace and Good Order", of the Town Code, which sets forth certain provisions intended to reduce the impact of certain nuisance offenses in the Town, including Section 86-2, "Trespass Upon Boats"; and

WHEREAS, the Town's code enforcement officials are unable to enforce Section 86-2 for practical reasons and the Town's law enforcement officers have resources in State law for preventing such trespasses; and

WHEREAS, for the preceding reasons, the Town deems Section 86-2 unnecessary to the administration of justice in the Town and the Town Council desires to conform the provisions of Chapter 86 to the Town's actual practice,

<u>Section 1.</u> NOW THEREFORE BE IT ORDAINED AND ENACTED by the Town of North Beach that Chapter 86, "Noise", Section 86-2 be and hereby is repealed in its entirety.

BE IT FURTHER ORDAINED by the Council of the Town of North Beach, that this Ordinance shall become effective twenty (20) days after approval by the Mayor or passage by the Council over the Mayor's veto, provided that a fair summary shall be posted in the Town Hall and the Town's webpage and sent out via the Town's listserv, and a message shall be sent by text message to residents subscribing to the Town's text message alert system, if any, that an ordinance is available for review on the Town's webpage.

AND BE IT FURTHER ORDAINED that this Ordinance shall be effective on the 30^{th} day of <u>November 2021</u> after being read at two consecutive Town Council Meetings.
