Minutes from the January 5, 2012 Work session

The Work Session was opened with a Public Hearing on the North Beach Comprehensive Plan. Mrs. Betty Jameson gave a timeline on the process of the Comprehensive Plan. The Planning Commission has been working on re-writing the Plan since 2008. The Planning Commission held several workshops and focus groups in regards to the Plan along with conducted several working meeting on the Plan. The Planning Commission held their Public Hearing in February 2011. After several changes to the Plan based on the Public Hearing input the Plan was sent to the Council for consideration in September 2011. Ms. Jameson explained to the Council and audience members the Council should leave the record open after this hearing for a specific time period. After that time period the Council can discus at their work session any comments received. At that time the Council can either amend the Comp Plan or adopted what has been presented. After the adoption of the Comprehensive Plan the Zoning Ordinance should be brought into compliance with the land use map adopted by the Comprehensive Plan. John Hofmann also spoke on behalf of the Plan giving an overview of each element and why it is being incorporated into the Plan.

#### **Public Comment:**

A) Jane Hagen, 9101 Greenwood Avenue: Is there a map of the proposed zoning change. (At this time there are no proposed zoning changes. That will take place after the adoption of the Comprehensive Plan if there are zoning changes to be made.)

There was no further comments. The Public Hearing was closed on a motion made by Randy Hummel. Seconded by Greg McNeil. The Hearing closed at 7:24 p.m.

- 1) Proposed improvements to the existing Public Works building and the Nature Park near the Public Works Building. Donnie Bowen explained to the Mayor and Council some ideas the staff has been discussing in regards to improving the building which would include, installation of restrooms, display area and vending machine area. Council members thought it was a good use of the building and is already amazed what a coat of paint can do for the building already. There is still planning and administrative work to be done with the plan.

2) Town Logo: A Town logo has finally been chosen. The plain NB with The Jewel of the Chesapeake Bay beside it will be the logo. Dawn will start using this on all publications. Ken Wilcox has volunteered his time to trademark the saying "The Jewel of the Chesapeake Bay."

Items DPW have been working on this report period in addition to routine task.

- 1) Continuing to work on new DPW shop and address issues in order to obtain UNO permit from the county. BG & E came out on 1-5-12 and hooked up permanent power to the building and removed old meter from existing building. Fire Marshall is scheduled to do their inspection on 1-12-12. Heating and air contractor has a few days work left to complete the heat system then the trades can call for final inspections. Expect to receive UNO permit soon.
- 2) DPW has been working on all snow equipment, installing and checking operation of equipment. Going over towns snow removal procedures with staff.
- 3) DPW staff have been working on old shop in order to make room to storage of Christmas decorations. Town staff with direction of Mayor and Council also is looking into multi uses for old shop.
- 4) DPW is working with beach patrol in removal of Christmas decorations.
- 5) Had meeting with sidewalk contractor for 7<sup>th</sup> street sidewalk and anticipate starting on 1-16-12.

#### Code Enforcement Report - January 12, 2012

Mayor Frazer, Town Council Members

December was a slow month, with the Holiday's a minimum number of letters were sent out and no civil citations were written. Since the first of the year six civil citations were sent to property owners; one is ready to be forwarded to the Attorney for legal action.

Properties on Annapolis, 5<sup>th</sup> Street, and 7<sup>th</sup> street have been abandoned; most for a long period of time and should be resolved sometime during the first quarter of the year.

Had a citizen complaint about a Pit Bull within the Town Limits. Dog was removed from the Town 1-9-2012 by the tenant. All citizens should understand that removing a Pit Bull from within the Town limits has legal issues and the process must play its course if the owner of the dog fails to comply.

During the 2011 calendar year over 171 Rental Inspections were performed and over 300 letters, violations or civil citations were written and addressed. Some comparisons from 2010 vs. 2011 are listed below showing the focus of the department. The items listed are considered to be the most important.

ORDINANCE NO: 11-11

AN ORDINANCE TO ADOPT THE 2009 INTERNATIONAL PROPERTY MAINTENANCE CODE AND THE 2009 INTERNATIONAL BUILDING CODE FOR RESIDENTIAL AND COMMERCIAL PROPERTIES AS THE CONTROLLING MAINTENANCE AND BUILDING CODES IN THE TOWN OF NORTH BEACH, MARYALND.

WHEREAS, in May 2003, the Mayor and Town Council of the Town of North Beach adopted Ordinance 03-02 which adopted the 2003 International Property Maintenance Code. This Code continues to govern property maintenance issues in the Town of North Beach; and

WHEREAS, there is now a 2009 International Property Maintenance Code which has recently been adopted by Calvert County and is used as the controlling property maintenance code throughout the County; and

WHEREAS, the Town now wishes to update its International Property Maintenance Code by adopting the 2009 addition of the International Property Maintenance Code which will bring it into sync with the County Property Maintenance Code; and

WHEREAS, currently new construction in the Town of North Beach is governed by the 2009 International Building Code for Residential and Commercial Properties and that Code is administered and enforced by Calvert County on behalf of the Town of North Beach. However, the Town has not officially adopted that building code so as to be able to enforce certain provisions of it on its own; and

WHEREAS, the most important section of the International Building Code for Residential and Commercial Properties which the Town would like to be able to enforce are those provisions governing existing properties. If the Town were to adopt the Code, the County would continue to govern new construction and issue permits but the Town would be empowered to enforce violations regarding building already in existence.

WHEREAS, based on the above, the Mayor and Town Council of the Town of North Beach have determined that it is in the best interest of the citizens of the Town of North Beach to adopt the 2009 International Property Maintenance Code and the 2009 International Building Code for Residential and Commercial Properties.

NOW, THEREFORE, it is this \_\_\_\_\_ day of \_\_\_\_\_ by the Mayor and Town Council of the Town of North Beach ORDAINED that the 2003 edition of the International Property Maintenance Code adopted by the Mayor and Town Council through Emergency Ordinance 03-02 is hereby repealed in its entirety.

The Mayor and Town Council of the Town of North Beach does ordain as follows:

Section 1. That the 2009 edition of the International Property Maintenance Code regulating and governing the conditions and maintenance of all property, buildings and structures within the Town of North Beach is hereby adopted as the Property Maintenance Code of the Town of North Beach, Maryland;

Section 2. That the 2009 International Building Code for Residential and Commercial Properties is hereby adopted as the governing building code for the Town of North Beach, Maryland. Under the provisions of this Ordinance, Calvert County, Maryland will continue to inspect and issue permits for new buildings within the Town of North Beach but the Town will be empowered to enforce the provisions of the Code for existing properties.

Section 3. That the 2003 International Property Maintenance Code and the 1990 BOCA building code now in effect in the Town of North Beach are both repealed in their entirety.

Section 4. That nothing in the Ordinance, or in the Property Maintenance Code, hereby adopted shall be construed to effect any suit or proceeding pending in any Court or any rights acquired or liability incurred or any cause or causes of actions acquired or existing under any act or Ordinance hereby repealed as cited in Section 1 of this Ordinance nor shall a just or legal right or remedy of any character be lost, impaired or effected by this Ordinance.

Section 5. Attached to this Ordinance as Exhibits 1 and 2 and officially made a part hereof, are copies of the 2009 International Property Maintenance Code and the 2009 International Building Code for Residential and Commercial Properties.

AND BE IT FURTHER ORDAINED, that upon passage of this Ordinance the same shall be authenticated by the signature of the Mayor and Town Clerk to be recorded among the Town books kept for that purpose and that a certified copy of this Ordinance shall be posted and advertised pursuit to Section 19-311 of the Town Charter.

AND, BE IT FURTHER ORDAINED that this Ordinance shall become effective on the day of \_\_\_\_\_, 2012 after having been read at two successive Town Council meetings Pursuant to 19-311 of the Town Charter.
