Staff Reports: Public Works Department, Code Enforcement, Waterfront Supervisor and Town Engineer are attached to this report.

BUSINESS ITEMS:

- a) Update on Performance Arts Center: Mayor Frazer introduced the Steering Committee for the planned Performing Arts Center in North Beach. A design of the building was projected for the audience to see. The Committee has been working for several months on the planning and design. The current design will be sent to the University of Maryland for a contest.
- b) Hotel/Proposal Discussion: Dick Rosano from the North Beach Economic Development Committee (this was not an EDC recommendation) gave a synopsis of what should be constructed on the parcel of land at 5th and Bay Avenue owned by RAR Associates. Mr. Rosano recommends the Town consider how important the construction of a small hotel in town is. He recommends the Town talk to a developer with hotel experience. Greg McNeil, liaison to the EDC recommends this study be sent to the EDC for a recommendation and report back to the Mayor and Council by November 2012.
- c) Contract for the Town of North Beach Public Ground Maintenance: MOTION made by Gwen Schiada to award the grass cutting to Earth Tech in the amount of \$10,350.00 for FY13. Seconded by Greg Dotson. All in favor. MOTION made by Gwen Schiada to award the Flower Bed Maintenance to Kelly's Tree and Lawn Service, Inc. in the amount of \$26,000.00 for FY 13. Seconded by Greg Dotson. All in favor.

Subject: Monthly Report

The following is a list of projects DPW has been working on in addition to routine task for this report period.

- 1) Re graded the north side of the public beach and added sixty tons of new beach sand to this area that needed attention from previous storms and erosion.
- 2) Created new parking area for classic cars to help improve safety and congestion on Friday nights along the beach front area and Bay Ave.
- 3) Completed the painting of the seawall on Atlantic Ave and added new traffic control signs on 9th and Atlantic.
- 4) Repaired a water main break on Atlantic Ave., sidewalk is scheduled to be repaired 7-11-12.
- 5) Worked with contractor on the installation of the heat and a/c unit in the visitors' center at the Nature Park to save on cost of system.
- 6) On Friday June 30 the area experienced a severe storm with high winds causing a lot of tree damage and power outages. All of the towns sewage pumping stations lost power and were running on back up generator power for a minimum of 18 hours some longer. The towns water system was also without power during this period. Power was restored to the well pump sites around 7pm on Saturday. The power outage caused damage to the control system of the wells and they had to be run in the manual mode until repairs were made on 7-5-12. DPW picked up tree limbs and debris for the week following the storm.
- 7) Installed the jelly fish net at the beach area on 7-3-2012.
- 8) Responded to a sewer call on Frederick Ave on 7-4-12 and found sewer line to be partially blocked, jetted sewer line and cleared blockage. The

following day jetted did maintenance jetting of the system in that area. Found large amount of grease in the main line causing blockage.

9) Repaired two breaks in sprinkler system along Bay Ave in the flower beds.

The following is the status of activities that are being worked on:

Timber Breakwater

Bids were received July 6, 2012. Attached is a summary of the bids received. Because the low bid of Dissen & Juhn at \$482,529.00 is more than what is available from the DNR Waterway Improvement Grant, we are exploring additional funding from the state and possible revisions to the design to get the project into compliance with the available funds.

Corps of Engineers Wetland Restoration

We have now received the attached project lists and Cost Estimates for the U.S. Army Corps of Engineers. Also attached is a plan showing the location and outline for the projects listed. The next step is for the project to transition from Section 206 (Evaluation and Preliminary Engineering) to Section 510 – Chesapeake Bay Environmental Restoration and Projection Program. The Town will soon be meeting with the Section 510 staff at the Corps of Engineers to discuss timing and financial aspects of the project.

DPW shop building

I am working on the final acceptance of the stormwater management by the County Engineering staff..

Boat Slip Dredge

We are pursuing permits and working with DNR on funding.

9th Street Flood Mitigation Project

After reviewing the draft final report from EA Engineering, the Environmental Committee asked for some changes in the final report which have been made by the Consultants. Attached is the Executive Summary for the report. The Environmental Committee is in the process of recommending a path forward for the project.

New Fishing Platform for Town Pier.

The application for State and Federal permits has been submitted. We are developing detailed structural engineering drawings for the project.

Wetland Trail

Design and permit applications are being prepared for Phase 1 which includes a connection from the Overlook pier to the parcel at the north end of Frederick Ave.

DNR Parcels

Recently, I have had discussions with the Department of Natural Resources and representatives from the State Attorney General's office on transfer of the State's interests in two parcels to the Town. The next step is for the Town's request for transfer be presented to the State Board of Public Works for approval. However, DNR will not commit to a schedule as to when this will happen.

Wastewater Treatment Plant Upgrade

The Treatment Plant upgrade is still in the MDE permitting phase. It is expected that the permit will be approved in the next few months and bidding will then begin with a bid date some time this fall. Construction would be started in the first quarter of 2013.

EXECUTIVE SUMMARY

The Town of North Beach (Town) retained EA Engineering, Science, and Technology, Inc. (EA) to conduct an evaluation of flooding in the vicinity of 9th Street between Bay Avenue and Atlantic Avenue and surrounding properties. The flooding has occurred periodically over time. including several times in 2011, resulting in the temporary closures of portions of 9th Street, Bay Avenue, and Annapolis Avenue during periods of high water. Specifically, this study:

- Identifies and summarizes other related studies and projects within this portion of the Town,
- Evaluates the existing storm drain and pump station infrastructure of 9th Street,
- Evaluates potential flood protection measures for implementation by the Town, and
- Provides cost estimates for permitting, design and construction of flood protection alternatives for a range of levels of protection.

The existing 9th Street storm drain system was installed in 1988 and larger capacity stormwater pumps were installed in 2002. Town staff has indicated that the existing storm drain infrastructure performs well during rainfall only events unless the intensity of a storm exceeds approximately 2 inches per hour, at which time runoff ponds in the low points of 9th Street for short periods of time. Staff has also indicated that during higher tides and/or storm surges in the Chesapeake Bay, the existing marsh north of 9th Street becomes inundated. The marsh and surrounding private properties were inundated several times in 2011, including the inundation of 9th Street and portions of Bay Avenue, Annapolis Avenue and Atlantic Avenue. During a high tide or storm surge scenario, the pumps cannot alleviate the flooding and the area remains flooded until the water surface in the Chesapeake Bay recedes.

For this evaluation, the 9th Street storm drain system was modeled using the Environmental Protection Agency's (EPA) Stormwater Management Model (SWMM). The SWMM model inputs include the sizes and elevations of storm drain pipes, the pumping capacity of the stormwater pumps, the stormwater runoff hydrographs from rainfall events, tide elevations in the Chesapeake Bay, and the existing storm drain inlet (grate) elevations at the ground surface. The model can predict the water surface elevation in the storm drain pipes and on 9th Street (during flooding) for a range of rainfall and tidal conditions. The model results are consistent with the observations described by Town personnel for recent rainfall and tidal flooding events. This confirmation is important for evaluating the accuracy of the model input parameters and results.

Flooding of 9th Street and surrounding properties can be caused by two different sources (or a combination of both): 1) stormwater runoff from rainfall events and 2) tidal surges in the Chesapeake Bay. The potential solutions for mitigating flooding are different for both of the flooding sources. This evaluation considered both sources.

entering around the back side of the berm via Bay Avenue. Evaluation of raising Bay Avenue is beyond the scope of this study. The berm will not protect the project area from flooding related to groundwater that would flow through the soil beneath the berm. The tide elevation in the Bay influences the groundwater elevation in the project area. The more permeable the soils are, the more quickly the Bay elevation will change the groundwater elevation. The relationship between the tide elevation and groundwater elevation is beyond the scope of this study and should be investigated further by collecting data described in Section 5 of this Report.

An opinion of probable cost is given for three different berm scenarios ranging in height. A berm to elevation 1.8 would be intermittent along the perimeter of the marsh and would fill in low-lying areas. This scenario would protect properties from inundation only up to a tide or storm surge elevation of 1.8 within the Bay. A berm with top elevation of 2.3 would be a continuous berm with an average height of approximately 0.6 feet (7 inches), and a berm constructed to elevation 2.8 would average 1.1 feet (13 inches) in height with a maximum height of almost 2 feet. A berm constructed to elevation 2.8 would protect against the 10-year stillwater elevation in the Chesapeake Bay meaning that there would still be a 10 percent chance of the Chesapeake Bay overtopping the berm in any given year.

It should be noted that none of the proposed alternatives will protect the area from all storm events. The analysis contained herein is an effort to determine and compare the protection elevation and opinion of probable cost in an effort to provide the Town cost-effective options for increasing the level of protection, knowing that the risk of flooding will not be eliminated with any of the proposed options. Storm return intervals and statistical analyses provide a snapshot of what type of storm events have occurred historically over time, but cannot guarantee that they will not be exceeded more frequently.

TOWN OF NORTH BEACH MAYOR AND TOWN COUNCIL

ORDINANCE NO. 12-02

A ZONING ORDINANCE TO REPEAL MOST OF THE ONSITE PARKING REQUIREMENTS FOR COMMERCIAL ESTABLISHMENTS WITHIN THE TOWN OF NORTH BEACH, MARYLAND.

WHEREAS, Section 5-300 of the Town of North Beach Zoning Ordinance contains the requirements for parking and loading within the Town of North Beach; and

WHEREAS, in Section 5-302 of the Parking and Loading Requirements, there is a table which lays out parking requirements. It is titled "Schedule of minimum off street parking requirements by land use". This table lays out the number of spaces required in residential areas, institutional, recreation and educational areas, commercial areas and unclassified areas; and

WHEREAS, the Town has studied the issue of off street parking requirements with commercial uses and has determined that the present system can and has been, a hindrance to the reasonable commercial development of the Town; and

WHEREAS, the Town has reviewed material and heard a report from a parking expert that talks about the advantages of eliminating most commercial off street parking requirements

WHEREAS, the Mayor and the Town Council of the Town of North Beach based on the above, have now determined that it is the best interest of the health, safety and welfare of the Town of North Beach to eliminate most off street commercial parking requirements within the Town of North Beach.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Town Council of the Town of North Beach the following:

- 1. The existing table 2 in Section 5-302 of the North Beach Zoning Ordinance is hereby repealed in its entirety.
- 2. There will be a new table 2 contained in Section 5-302 of the Zoning Ordinance. That table is marked as Exhibit 1 and is attached to and hereby made a part of this Ordinance.
- 3. Pursuant to Section 7-301(b) of the Town of North Beach Zoning Ordinance which concerns the initiation of a Zoning amendment by the introduction by the Town Council of an Ordinance to amend, this Ordinance upon introduction shall be issued to the Planning Commission and the Zoning Administrator of the Town of North Beach.
- 4. Pursuant to Section 7-303 of the Town of North Beach Zoning Ordinance a joint public hearing with the Mayor and Town Council and the Planning Commission will be scheduled to consider this Ordinance.

ORDINANCE NO: 12-04

AN ORDINANCE TO AMEND CHAPTER 26 OF THE CODE OF THE TOWN OF NORTH BEACH TO PROHIBIT DANGEROUS ANIMALS

WHEREAS, the Mayor and Town Council have determined that prohibiting from the Town any animal that, without provocation, wounds, bites, injures or kills a human being, another animal or livestock, or is being trained or has been trained to attack is to protect the health, safety and welfare of the citizens of the Town, and;

WHEREAS, in 2000 the Mayor and the Town Council passed ordinances to amend the Town Code that prohibited the keeping of "pit bulls" in the Town because it was determined that "pit bull" breeds, including the Staffordshire Bull Terrier, the American Staffordshire Bull Terrier, the American Pit Bull Terrier, and any genetic combination thereof, were inherently dangerous animals, and;

WHEREAS, the Mayor and the Town Council have determined that the major factors that cause the dangerousness of animals is not a specific breed of the animal but instead the disposition of specific animals and how the owner of the animal raises the animal, and;

WHEREAS, the Mayor and the Town Council have determined that confirming the exact breed of dog by genetic testing is prohibitively expensive and highly unreliable but determining the dangerousness of an animal by its actions are cost-effective and highly accurate, and;

NOW, THEREFORE, be it resolved by the Mayor and the Town Council of the Town of North Beach, Maryland that Section 26-3 of the Code of the Town of North Beach will be amended as follows:

Dogs running at large and dogs on the sand beach; Dangerous Animals

- A. No person shall own or harbor within the Town of North Beach any dog unless such dog is licensed as provided by the ordinances and regulations of Calvert County. All ordinances and regulations of Calvert County concerning dogs shall apply within the corporate limits of the Town of North Beach. In addition, this includes the provisions of the Calvert County Code which call for all dogs to be on a leash when in the company of their owner outside the confines of the owner's property. In addition, it is expressly prohibited for any dog to be on the town beach, whether said dog be at large or on a leash. It is the intention of the Council that dogs are prohibited on the sand beach under all circumstances.
- B. Dangerous Animals. Based on numerous instances in the Town of North Beach and Calvert County, the Mayor and Council have determined that dangerous animals are of particular nuisance and danger to the health, safety and welfare of the public. Therefore, except as otherwise permitted by this article, the ownership of a dangerous animal is hereby prohibited within the Town of North Beach. In addition, it is prohibited for a dangerous animal to be on any town right-of-way, including streets, the boardwalk and/or the beach, at any time, whether with its owner or not. It is the intention of this article that dangerous animals not have any contact with the public within the Town of North Beach.
- C. Dangerous animals presently owned within town limits. Any resident of the Town of North Beach who owns a dangerous animal at the time of the passing of this article may continue to own that animal within the Town of North Beach under the conditions stated in the Code of Calvert County, Chapter 7, Part 9, Article I, section 7-9-103.
- D. Any person not owning a dangerous animal pursuant to this article seen with a dangerous

animal within the Town of North Beach will be asked to remove said animal from the town immediately. If the animal is not removed, it shall be subject to confiscation by the town and will be turned over to the Calvert County Animal Control Officer where it can be claimed by the owner within the rules and regulations of county law. In addition, the owner shall be subject to the provisions of § 26-8 of this chapter which states that violations will be deemed to be a municipal infraction.

E. Any town resident owning a dangerous animal pursuant to the provisions of this article found to be in violation of this article shall be guilty of a municipal infraction as stated in § 26-8 of this article. In addition, any town resident who owns a dangerous animal pursuant to this article who receives a second municipal infraction for a violation of this article will be subject to having the animal confiscated by the town and turned over to the Calvert County Animal Control Officer for disposal pursuant to county law. All code enforcement officials of the Town of North Beach, including Deputy Sheriffs and Beach Patrol Officers, will have the authority to issue citations under this section.

F. Appeals.

(1) For the purposes of this article only, there is hereby created the Town of North Beach Animal Control Committee. This Committee will be separate and apart from any other committee within the town, but will consist of the members of the Town of North Beach Board of Appeals. It is the intention of this article that any person appointed to the North Beach Board of Appeals under the authority and rules contained in Article 8 of the Town of North Beach Zoning Ordinance shall automatically be members of the Town of North Beach Animal Control Committee for as long as they are members of the Town of North Beach Board of Appeals. The members will sit as the Town of North Beach Animal Control Committee only when dealing with appeals filed pursuant to this article. When holding a hearing on any appeal, the Board may not take any action unless there are at least three

- members present, and no action will be valid unless at least three of the sitting members of the Committee vote in the affirmative.
- (2) Within 30 days of a dangerous animal being designated as dangerous or being confiscated under the provisions of this article, the Town of North Beach Animal Control Committee will review the actions of the town official and decide if the sanctions mandated in this article are being properly applied. The Town of North Beach Animal Control Committee may issue a stay of the designation of the animal as dangerous and confiscation of the animal until the resolution of the appeal. In this regard, the Town of North Beach Animal Control Committee may either uphold the decision of the town official to confiscate the dangerous animal or reverse that decision. During the pendency of an appeal, the dangerous animal will be held under the control of the Calvert County Animal Control Officer if a stay is not issued, but will not be disposed of until the appeal is final. If the Town of North Beach Control Committee votes to reverse the decision of the town officials, then the animal will be returned to the owner. All decisions of the Town of North Beach Animal Control Committee in this regard are final. The Town of North Beach Animal Control Committee will issue decisions only after a public and open hearing and after public and open deliberations.

G. Definition of Dangerous Animal.

- (1) For purposes of this article, "dangerous animal" means:
 - i. any animal that without provocation, wounds, bites, injures or kills a human being, another animal or livestock, or
 - ii. any animal designated by another jurisdiction, County, or State as dangerous under similar procedures as the Town and Calvert County.

(2) Exceptions

i. Animals shall not be declared a "dangerous animal" if the threat, injury, or damage was

sustained by a person who, at the time:

- (a) Was committing a willful trespass or other tort upon the premises occupied by the owner, keeper or custodian of the animal;
- (b) Was teasing, tormenting, abusing, or assaulting the animal;
- (c) Has been observed or reported to have teased, tormented, abused, or assaulted the animal; or
- (d) Was committing or attempting to commit a crime.
- ii. Animals shall not be declared dangerous if the animal was protecting or defending itself, its young, its owner or caretaker, another animal, another person, or responding to pain or injury.
- iii. Animals owned by a governmental or law enforcement unit are exempt from being declared dangerous.

ORDINANCE NO: 12-07

AN ORDINANCE TO AMEND THE TOWN OF NORTH BEACH RENTAL HOUSING LICENSE ARTICLE TO ESTABLISH A NEW INSPECTION PROCESS AND TO ESTABLISH A PROCESS FOR THE CODE ENFORCEMENT OFFICER OF THE TOWN TO OBTAIN AN ADMINISTRATIVE SEARCH WARRANT IN CASES WHERE HE IS DENIED ACCESS FOR RENTAL INSPECTIONS.

WHEREAS, in Section 69-14 of the North Beach Town Code calls for rental housing licenses to be obtained on an annual basis and inspected annually or as the Code Enforcement Officer deems necessary; and

WHEREAS, the Town of North Beach Mayor and Town Council have determined that the rental housing stock within the Town has increased and improved steadily over the years, therefore the Mayor and Town Counsel feel that regular annual inspections are no longer necessary and are creating an over-burdensome workload for the Code Enforcement Officers; and

WHEREAS, Mayor and Town Council of the Town of North Beach have now determined that it would be in the best interest of the citizens of the Town of North Beach to establish a three (3) year rental housing inspection schedule; and

WHEREAS, Section 69-16 of the Rental Housing License Article calls for inspections of rental properties at the time of application, at the time of a renewal of a license or upon receiving a complaint that a until has substandard livability conditions; and

WHEREAS, the above referenced section calls for a property owner to give access to the Town Code Enforcement Officer for such inspection upon reasonable notice. Presently there is not a section that lays out the proper procedure if a landlord refuses to provide access for an inspection; and

WHEREAS, the Mayor and Town Council of the Town of North Beach have determined that it is in the best interest of the health, safety and welfare of the Town of North Beach to carry out rental inspections and have a remedy if a landowner refuses access for inspections.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Town Council of the Town of North Beach the following:

- Section 1. Section 69-14 of the North Beach Town Code is hereby amended as follows:
- A. All rental housing units shall be required to obtain a license as issued by the Town of North Beach for the privilege of renting housing units within the corporate limits of the Town.
- B. A rental housing license shall be on a three year renewal (obtained on an annual basis) and shall be inspected one time within each three (3) year cycle or as the Code Enforcement Officer deems necessary as a result of complaints received for substandard conditions.

- C. Rental housing licenses shall be billed annually (on July 1st of each fiscal year).
- Section 2. Section 69-16 of the North Beach Town Code is hereby amended as follows:
- A. Upon applications for said license and prior to the issuance and/or renewal and/or upon registered complaint received by the Town of substandard livability conditions, there shall be an inspection conducted by an authorized agent of the Town of said rental housing units for compliance with the Building Code Administrator (BOCA) National Property Maintenance Code, as amended from time to time.
- B. The owner(s) of title or a legally designated agent (designation must be in writing) of said rental units shall, upon application for license or for license renewal and scheduling of inspection with North Beach Code Enforcement Officer, accompany the North Beach Code Enforcement Officer into the premises for the purpose of conducting the required and/or mandated inspections. Inspection for a rental housing license shall be scheduled once every three (3) years or as required by the North Beach Code Enforcement Officer as a result of a complaint for substandard conditions. Scheduling for inspections is made by the North Beach Town Hall personnel.
- C. If upon presentation of proper credentials and if after giving reasonable notice of the scheduling of an inspection, the Code Enforcement Officer or his or her agent is denied entrance to a rental property, said officer will give to the denier official notice of a subsequent inspection not longer than ten (10) days hence and at a designated hour. If within ten (10) days upon a second request to inspect the same premises the Code Enforcement Officer or his or her agent is again denied entrance, said Code Enforcement Officer shall petition the appropriate legal body and shall seek to acquire a warrant permitting legal entrance into said premises.
