Dear Ms.LaGrange:

Per your public comments from January 12, 2023, Town Council Meeting please find my response.

I reached out to our Sheriff's department and asked them to send me information to help answer your question and have included their response below. I believe because of the growing number of these vehicles and concerns this will become an agenda item for the town in the coming months. If you believe someone is acting dangerously or violating the law, please call 410-535-2800 and one of the Beach Deputies will be sent to the location. Thanks again for reaching out and let me know if you have any other questions.

Golf Carts: Golf carts are not allowed on any public roads in Maryland, whether Federal, State, Local or Municipal, except in the city of Crisfield.

Electric scooters and electric bicycles: These must follow the same rules of the road as bicycles. There is no titling or registration process for these.

Mopeds and motor scooters: If these meet the requirements of having an engine less than 1.5hp or less than 50cc, they must properly registered and decaled. The operators must possess a valid driver's license or moped permit and have proof of insurance. No helmet is required.

Low speed vehicles: These vehicles must be properly registered with the MVA, capable of a speed of 20, but no more than 25mph, have 4 wheels, be electric, weigh less than 2500lbs, and comply with all safety regulations set forth by the Federal Motor Carrier. These vehicles may only be driven on roads with a posted speed limit of 30MPH or less. *Some of these registered low speed vehicles may look similar to golf carts, however they are more robust, have brake lights, headlights, mirrors, etc. and meet the minimum safety standards set forth, however they are not your run of the mill golf carts and must be registered."

Minibikes or pocket bikes: These cannot be operated on public roads in Maryland.

Dear Ms. Lawton:

Per your public comments from January 12, 2023, Town Council Meeting please find my responses.

Meeting videos are not required by law to be posted; therefore, there is no specific time frame for doing so, and just as with written minutes, it may depend on staff resources. It is not unusual, especially in smaller jurisdictions, due to the press of other work for a jurisdiction's Clerk or due to other circumstances for the posting to be delayed a month or two. Moving forward, the Town of North Beach will endeavor to post meeting videos; including Town Council Work Session, Town Council Meetings, Planning Commission, Ethics Commission, Board of Appeals, and Tree Committee within 30 days of the meetings, and will endeavor to post written minutes to the town website within 30 days from approval of minutes.

All public bodies must convene an open session prior to adjournment into a closed session. There is no requirement that there be public notice that the entity is considering adopting regulations, other than the ordinary notice of the meeting, which can be accomplished by the posting of an agenda. The agenda must be "made available" to the public at least 24 hours in advance; the State statute does not say it must be "posted."

The Ethics Commission has the authority under Section 9-3 (D) of the Town Code to adopt its own regulations without approval from the Town Council.

I will take into consideration the establishment of a hotline to report fraud, waste, or abuse.

Answers to Ms. Lawton's questions:

Response to Question 1:

The videos are not required by law to be posted. There's no actual hard and fast requirement to post minutes or video except "to the extent practicable". (If a jurisdiction doesn't maintain a website, I imagine it would not be "practicable" to post them, for example). I think it is practicable for North Beach, so if the Town is posting the video in lieu of approving written minutes, the video should be posted reasonably promptly under the circumstances. If there are written minutes, the Town can post those instead of the video, although I think there's ordinarily no reason not to post the video.

There is no specific time frame for doing so, and just as with written minutes, it may depend on staff resources. It is not unusual, especially in smaller jurisdictions, due to the press of other work for a jurisdiction's Clerk (or other person responsible for the minutes) or due to other circumstance (vacation, illness, or something else) for the posting of minutes to be delayed a month or two.

Response to Question 2:

2.a. A body must meet in open session before adjourning to closed session.

2.b. There is no requirement that there be public notice that the entity is considering adopting regulations, other than the ordinary notice of the meeting, which can be accomplished by the posting of an agenda. The agenda must be "made available" to the public at least 24 hours in advance; the statute does not say it must be "posted". (Note that there isn't an actual flat requirement for written notice — the notice must be in writing if "reasonable". Ordinarily, it would be reasonable to give written notice.)

The Ethics Commission has the authority under § 9-3(D) to adopt its own regulations without approval from the Town Council.

Response to question 3. This is not a legal question. Whether to establish such a hotline is a question for the Mayor and/or the Council, depending on whether it would be accomplished administratively or legislatively and whether additional appropriations would be necessary.
