## **BUSINESS ITEMS**

**North Beach 5<sup>th</sup> Street Outfall Pump Project:** A Request for Proposals was prepared, and bids were received for the 5<sup>th</sup> Street Outfall Pump Project. Two bids were received for this project from Shafer, Troxell & Howe, Inc along with Sherwood Logan and Associates. The bid from Shafer, Troxell & Howe was not a valid bid because they did not fill out the appropriate bid sheet. Their bid was not accepted. Donnie Bowen, Public Works Director prepared a staff memo. His recommendation currently is to award the bid to Sherwood-Logan and Associates in the amount of \$45,908.00. **MOTION** made by Jane Hagen to accept the bid as recommended. Seconded by Elizabeth Lawton. All in favor. **Motion carries.**

**Interview of Interested Candidates for Councilmember Vacancy:** There were six Town Residents who submitted their interest for the Council Vacancy. Out of the six, five were interviewed. They were Gene Mead, Lauren Kabler, Mary Mayhew, Susan Shaw and Cheryl Greene. Each candidate was asked a series of questions by fellow councilmembers. After the interviews the Mayor and Councilmembers entered Closed Session to discuss the interviews.
