three contractors. Donnie Bowen is recommending the contract is awarded to Chesapeake Environmental Solutions from Delmar, MD. Calvert County Government has agreed to split the cost of the pipe cleaning project. **MOTION** made by Elizabeth Lawton to award the Contract to Chesapeake Environmental Solutions in the amount of the base lump sum price of \$86,662; hauling of materials - \$37.50 per ton (approximate 535 tons = \$20,062,50.
