The following is a list of task the Public Works Department has been working on in addition to routine task.

- 1) Performed routine flushing of the town water system to remove built up iron and sediment in main water lines. Check out hydrants for proper operation. Redirected one hydrant in Burnt Oaks to allow fire department better access for connection of fire truck.
- 2) Tested all operation systems in sewer and storm water pumping stations for proper operation. Tripped alarms and made sure all were operating correctly. Made sure alarm system notified staff of alarm condition.
- 3) Responded to clean up street and sidewalk area after flooding from heavy rain on one occasion this report period. Followed up with cleaning of storm drains on Bay Ave. Removed grates and cleared inlet pipes of leaves and debris, jetted pipes under Bay Ave. Shot grades on inlet at Bay and 5th street and verified inlet is 30+ inches below Bay level during normal tide.
- 4) Met with two home owners and went over storm water issues on their property and recommended steps that could be taken to improve drainage.
- 5) Mark Dougherty, DPW operator, attended Maryland Rural Conference and attended training classes on water and sewer operations.
- 6) Have had a few meetings with staff and Calvert County Water & Sewer department going over flows that go through the town system. Did a field walk through of sewer system to show water and sewer department head Mr. Wayne Rather sewer entry points from Calvert to North Beach. Will continue work to come up with new agreement for pump station shared cost operation and maintenance.

- 7) Met with design engineer working on site plan for development plan for 5th and Bay. Along with Rick Crump and Paul Woodburn provided comments and responses to plan to date.
- 8) Worked with contractor and installed new electrical service panel and related equipment for new water station.
- 9) Cleaned up trash several times that was dumped in the Greenwood Averight of way between 4th and 5th street.

The following is the status of activities that are being worked on:

Maryland SHA Rte. 261 SHA Upgrade Project (9th Street to Anne Arundel County)

SHA's environmental and highway design work is progressing toward a planned construction start for the spring of 2020. The proposed detour Route is finalized and will require closure of 261 during construction. Design Drawings are at 85% level have been received by the Town as well as the MDE Environmental Impacts Permit. We have provided input back to SHA as needed. The SHA is requesting Right-of-Way from the Town to perform their work. We will review request & provide recommendations to the Mayor & Council in the coming weeks. The state has approached the town with a proposal to direct project runoff to existing town inlets. We have reviewed their request and responded.

Maryland SHA Rte. 261 Boardwalk (9th Street to Anne Arundel County)

Preliminary design is complete and TAP (Transportation Alternatives Program) grant Monies will be sought for 2019. The Town prepared an updated State grant package request for the next fiscal year cycle. Official feedback will be provided from SHA in the coming weeks. (No New Update).

Stormwater Flood Pump Upgrade and 9th & Atlantic upgrades:

The existing stormwater pump station is not designed to adequately handle frequent localized flooding. The Town continues to seek funding opportunities to cover this proposed work. Capital funding for 2019 is also being sought through the Maryland Water Quality Financing Administration. Also, all Town Stormwater pump stations are being reviewed to determine if improvements or efficiencies can be added. (No New Update).

Flood Mitigation Plan:

Calvert County Department of planning and zoning issued a draft flood mitigation plan for the town of North Beach. The plan is a guide that outlines flood issues and sea rise issues in the Town along with potential mitigation considerations for current conditions and into the year 2100. Nine (9) recommendations came out of the study, many of which are or have already been implemented and others are being implemented. Further review and discussion of the document by the town will commence soon, upon which it can be brought to the Mayor & Council for consideration. The Town has completed a flood evacuation Route plan & provided on line links to obtain valuable emergency information. The Mayor will be looking at forming a flood resilience task force to look into short and long term flooding issues within the Town. (No New Update).

Public Works Yard – Well Building

We completed engineering construction drawings to upgrade and raise the existing 30+ year old well house building. The well building upgrades are moving forward. (On-Going).

Storm Drain System Maintenance:

We are working with the Mayor, Donnie and the public works staff to develop a 5 year storm drainage maintenance and overall infrastructure improvement plan. Overall Topographic & existing utility plans have been prepared and will be updated with required upgrades in the coming months. We have provided the Town with a concept level set of plans for review and comment. (No New Update).

Sewer Meter/ Calvert County Connections:

Calvert County sewage effluent mixes with the town effluent before being pumped together to the Waste Water Reclamation Facility in Chesapeake Beach. We have provided the county with our updated EDU analysis. Donnie requested the County perform a sewer system smoke test. A follow up letter will be forwarded to the County encouraging them to do a smoke test on their system to ensure there are limited infiltration points within their system and provide the Town with a copy of the test results. A letter has been sent to the County requesting an update to their review of infiltration for their sewer system. We also met with the County Director of Public Works and his engineering staff to discuss a partnership to work with the County and joint water, sewer and stormwater issues. Ongoing discussions with the County regarding inter jurisdictions stormwater, water and sewer issues are being held. (On-Going).

Library Site:

We have prepared an updated Library Site Concept water Plan which will be provided to the County. We have met with the County to discuss a revised Memorandum of Understanding (MOU) to move the Library Project forward. Follow up & clarification questions continue with the County. (No New Update).

Shoppes at North Beach:

We have reviewed the proposed project for layout, access, parking, utility Stormwater, Water and Sewer and Floodplain impacts and provided comments to the zoning administrator. Of importance we have reviewed the existing storm water pump station and have recommended upgrades to improve efficiencies as part of this project.

 - The Town of North Beach assured the public that the Calvert County Sheriff's Office was on top of the investigation and would adequately staff the market with deputies to ensure safety and enjoyment.
- Reached out to town businesses seeking promotions or specials that could be shared with the End Hunger group.
 These promotions and specials have been passed on to all teams of the Dragon Boat Festival. My goal is to attract these extra guests in North Beach to our businesses.

Horseshoe Crab Beach surveys- We have been conducting beach and waterfront surveys for active mating crabs. We have not had any reported yet.
