The following is a list of task the Public Works Department has been working on in addition to routine task.

- 1) Preformed routine flushing of the town water system to remove iron deposits in system. While flushing was done crew inspected operation of fire hydrants and blow off valves for proper operation. Generated repair list from this inspection.
- 2) Responded to residents request to look at Greenwood Ave north of Second Street. Home Owner at 3902 had concerns with road being too narrow for traffic to pass safely on Greenwood Ave and has witnessed several vehicles running off the road and into ditch line on east side of Greenwood.

 Roadway is only 16 feet wide in this area. Normal travel lane is eleven feet wide (twenty two feet total). There is room to widen roadway in this area.

 Met with contractor and got proposal to address issues in this area.
- 3) DPW installed poles for new panel for the water station new electric service. Receive all components for new service hook and plan to work with electrician this week to have installed.
- 4) New water meters have been ordered and have contacted installer to schedule installation of new meters and radio read data collectors when we receive shipment of meters. Meters currently have a five week lead time.
- 5) DPW crew collected water meter readings for billing, inspected meter pits for problems and currently generation work order repairs for problem pits.
- 6) DPW worked with contractor and did two more new water and sewer service connections for new homes.
- 7) Continue to work with staff and Calvert County on new shared agreement for operation of sewer pump stations.

- 8) DPW crew is working on repainting stop bars at intersections, will move to repaint crosswalks on Bay Ave when stop bars are completed.
- 9) Attended SHA meeting on the MD 261 project. Public information meeting is scheduled for May 20 at Windy Hill Middle School 7 to 9 pm. Project still on schedule for now.

The following is the status of activities that are being worked on:

Maryland SHA Rte. 261 SHA Upgrade Project (9th Street to Anne Arundel County)

SHA's environmental and highway design work is progressing toward a planned construction start for the spring of 2020. The proposed detour Route is finalized and will require closure of 261 during construction. Design Drawings at 75% level have been received by the Town as well as the MDE Environmental Impacts Permit. We have provided input back to SHA as needed. The SHA is requesting Right-of-Way from the Town to perform their work. We will review request & provide recommendations to the Mayor & Council in the coming weeks. The state has approached the town with a proposal to direct project runoff to existing town inlets. We will review their request.

Maryland SHA Rte. 261 Boardwalk (9th Street to Anne Arundel County)

Preliminary design is complete and TAP (Transportation Alternatives Program) grant Monies will be sought for 2019. The Town prepared an updated State grant package request for the next fiscal year cycle. Official feedback will be provided from SHA in the coming weeks. (No New Update)

Stormwater Flood Pump Upgrade and 9th & Atlantic upgrades:

The existing stormwater pump station is not designed to adequately handle frequent localized flooding. The Town continues to seek funding opportunities to cover this proposed work. Capital funding for 2019 is also being sought through the Maryland Water Quality Financing Administration. Also, all Town Stormwater pump stations are being reviewed to determine if improvements or efficiencies can be added. (No New Update)

Flood Mitigation Plan:

Calvert County Department of planning and Zoning issued a draft flood mitigation plan for the town of North Beach. The plan is a guide that outlines flood issues and sea rise issues in the Town along with potential mitigation considerations for current conditions and into the year 2100. Nine (9) recommendations came out of the study, many of which are or have already been implemented and others are being implemented. Further review and discussion of the document by the town will commence soon, upon which it can be brought to the Mayor & Council for consideration. The Town has completed a flood evacuation Route plan & provided on line links to obtain valuable emergency information. The Mayor will be looking at forming a flood resilience task force to look into short and long term flooding issues within the Town.

Public Works Yard - Well Building

We completed engineering construction drawings to upgrade and raise the existing 30+ year old well house building. The well building upgrades are moving forward. (On-Going)

Storm Drain System Maintenance:

We are working with the Mayor, Donnie and the public works staff to develop a 5 year storm drainage maintenance and overall infrastructure improvement plan. Overall Topographic & existing utility plans have been prepared and will be updated with required upgrades in the coming months. We have provided the Town with a concept level set of plans for review and comment.

Sewer Meter/ Calvert County Connections:

Calvert County sewage effluent mixes with the town effluent before being pumped together to the Waste Water Reclamation Facility in Chesapeake Beach. We have provided the county with our updated EDU analysis. Donnie requested the County perform a sewer system smoke test. A follow up letter will be forwarded to the County encouraging them to do a smoke test on their system to ensure there are limited infiltration points within their system and provide the Town with a copy of the test results. A letter has been sent to the County requesting an update to their review of infiltration for their sewer system. We also met with the County Director of Public Works and his engineering staff to discuss a partnership to work with the County an joint water, sewer and stormwater issues. Ongoing discussions with the County regarding inter jurisdictions stormwater, water and sewer issues are being held. (on-going)


Library Site:

We have prepared an updated Library Site Concept water Plan which will be provided to the County. We have met with the County to discuss a revised Memorandum of Understanding (MOU) to move the Library Project forward. Follow up & clarification questions continue with the County. (No New update)

Shoppes at North Beach:

We have reviewed the proposed project for Stormwater, Water and Sewer and Floodplain impacts and provided comments to the zoning administrator.




